ACCEPTING APPLICATIONS FOR HIGH SCHOOL LEADERSHIP TRIP TO D.C.

ACREC will send 2 students on an all-expenses paid Youth Tour trip to Washington, D.C., in June

At Allamakee-Clayton Electric Cooperative, one way we invest in the next generation of rural Iowa leaders is by participating in the national Electric Cooperative Youth Tour program. We're looking for high school sophomores and juniors with a passion for government and public service to apply for a once-in-a-lifetime trip to our nation's capital in June.

Two students will be selected from eligible candidates to attend the 2023 Youth Tour in Washington, D.C., from June 17-23, along with 40 other student leaders from Iowa. The Iowa Youth Tour group will join with hundreds of students from across the country as they learn more about electric cooperatives and American history and come home with a greater understanding of their role as American citizens. Students will also learn about U.S. government and meet with their members of Congress. On the trip, students take in the sights of D.C. as they visit monuments, museums, and historical landmarks. Students who go on Youth Tour often call it the trip of a lifetime!

We are accepting Youth Tour applications through Tuesday, January 31. Children of ACREC members are eligible to apply. Applicants must be a current sophomore or junior in high school. Students must complete the application and return it to ACREC by the deadline. All applicants will complete an open-book exam. The Co-op will interview the students with the top-five scores and will choose two finalists to go to Washington, D.C. 2023 INCENTIVE REBATES

It's a new year and a new opportunity for ACEC members to save on energy efficient purchases. Allamakee-Clayton's program will remain similar to 2022, offering rebates on many items, including clothes washers, electric water heaters, HVAC units (air source heat pumps and geothermal units), lighting and more. ACEC annually publishes a list of energy efficient items that are eligible for a rebate when a member makes a qualifying purchase and submits the required paperwork.

Listed on each form is the eligibility criteria for each category. Rebates begin at \$0.50 up to \$800 for certain items. To receive the rebate, the member must purchase a qualifying item, fill out the appropriate form and return the form and documentation to the Co-op within three months of purchase or installation (clarified on the form). Members must

install equipment within the Cooperative's service territory and, in most cases, must be ENERGY STAR® rated. **#3904A**

"Technology improves every year, which makes energy efficient products more affordable and readily available for our members," said Hollee McCormick, general manager. "Our partnership with Dairyland Power Cooperative, our wholesale power provider, to offer a robust program is a great example of cooperation among cooperatives to not only power our local communities, but also help improve quality of life for members."

ACEC HELPS ACCESS \$1.5 MILLION FOR CHILD CARE CENTER

ACEC, along with MiEnergy Cooperative (Cresco/Rushford, Minn.) and Dairyland Power Cooperative, joined forces to support a new childcare facility in Decorah.

Sunflower Child Development Center is constructing a new 29,000 square foot facility called the Northeast Iowa Child Development and Discovery Center. Located at 902 Commerce Drive, construction began on the project last fall. The new facility will replace the current, aging center and will support a capacity of 215 children, with room to expand beyond 300.

A check presentation was held on December 13, with contributions from all three cooperatives. ACEC accessed \$1.5 million on behalf of the center through the USDA's Rural Economic Development Loan and Grant (REDLG) program. MiEnergy helped access \$1.86 million through the same program. Dairyland donated \$5,000 - \$2,500 from Dairyland and a match from CoBank, a national cooperative bank, through CoBank's Sharing Success Program.

"Childcare is a critical necessity for the community," says



Representatives from Allamakee-Clayton Electric Cooperative, MiEnergy Cooperative and Dairyland Power presented checks to Sunflower Child Development Center for the new childcare facility last month.

Allamakee-Clayton Electric Cooperative Executive VP/ General Manager Hollee McCormick, adding how this will not only help Winneshiek County but also all of the families in neighboring communities.

The new facility will include 19 classrooms, with direct access to age-appropriate outdoor playgrounds. Classrooms will be separated into STEAM (science, technology, engineering, art and math) learning areas, indoor play areas and other common-use spaces. Spaces will be open to the public in the evenings and on weekends.

Construction is expected to last 18 months, opening to the public in the summer of 2024. ■

VEGETABLE CHEESE SOUP

Makes 2 qt.

- 1 c. finely chopped celery
- ½ c. finely chopped carrots
- ¼ c. finely chopped onion
- 1 qt. chicken broth
- 1 qt. milk
- 1 lb. cubed Velveeta cheese
- ½ c. butter
- ½ c. flour
- ½ tsp. dry mustard

Instructions

1. Cook celery, carrots, onion and chicken broth until tender.
2. In a separate pan, scald 1 qt. milk. Add cubed Velveeta cheese and stir until melted.
3. In a saucepan, melt butter. Add flour and dry mustard. Mix well, then stir into milk and cheese mixture. Mix well, then stir in the hot vegetables and broth they were cooked in. Serve hot.

My favorite thing about this soup is as long as I have plenty of celery and carrots and onion, I can cook another batch of vegetables and broth, cool and freeze. Next time I want to make this soup, just thaw and heat the vegetables/broth and continue the rest of the recipe and you have soup made quickly with no mess.

SLOW COOKER LOADED BAKED POTATO SOUP

- 4 c. potatoes, about 3-4 large russet potatoes peeled and diced

- 1 small onion, chopped
- 3 c. chicken broth
- 4 tbsp. butter
- ¼ c. flour
- ¼ c. sour cream
- 1 ½ c. heavy cream (half and half will also work)
- Salt and pepper to taste

Optional ingredients

- Bacon, cooked and crumbled
- 1 ½ c. cheddar cheese
- Green onions

Instructions

1. Add potatoes, diced onions, and chicken broth to your slow cooker. Cook on low for 4-6 hours or high for 3-4 until potatoes are tender.
2. About 30 minutes before it is done, in a medium saucepan, melt the butter. Whisk in flour and cook until bubbly. Slowly add heavy cream and sour cream. The mixture should be thick. Add this to the soup and stir. Continue to cook in the slow cooker for 20-30 minutes.
3. Serve with toppings or you can also stir them all into the soup. Enjoy!
